4. **Employer Sponsorship** — get job offer letter from employer listed on IND sponsor list.
5. **Work & Residence Permit Application** — employer submits GVVA / HSM / Blue Card.
6. **Entry Visa (MVV)** — if needed before relocation.
7. **Arrival & Registration** — register with municipality (BRP) and start work.
